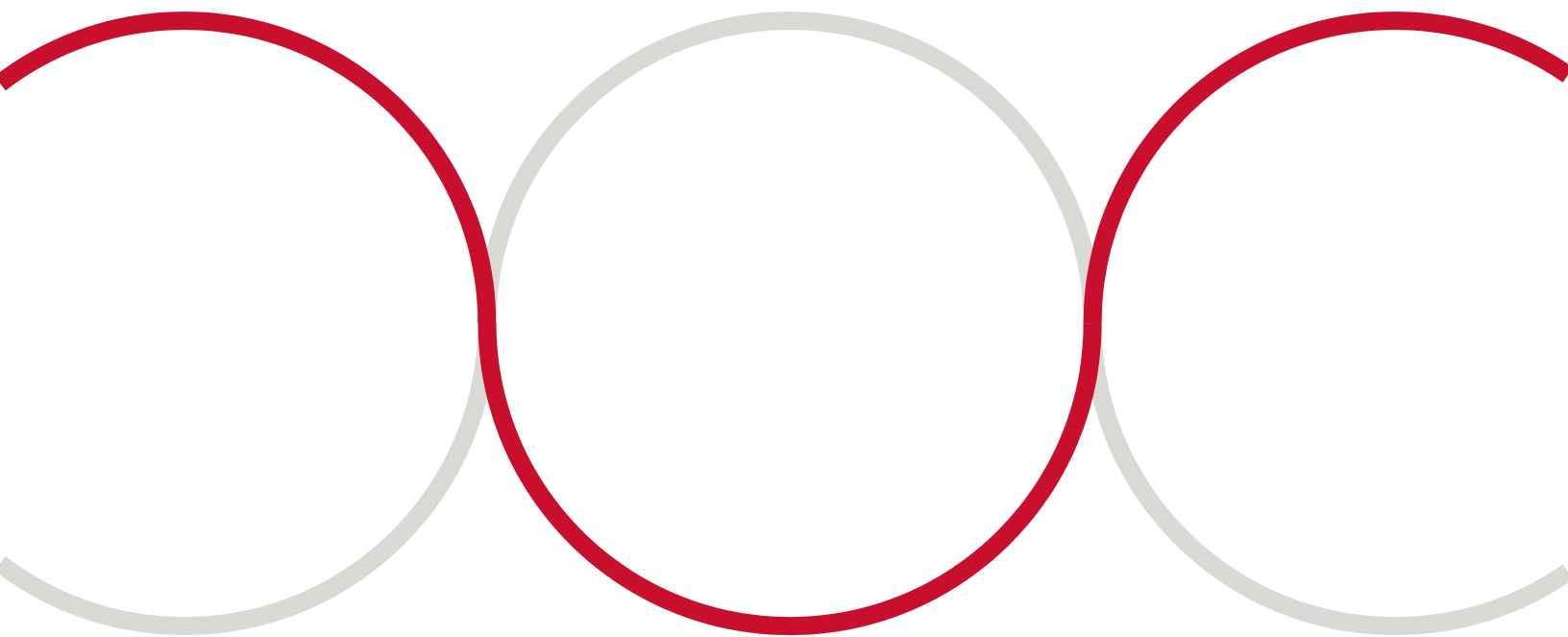

## General information

### Is SC Johnson the same company?

No, SC Johnson is an independent company with no relation to Johnson & Johnson, the Johnson & Johnson Foundation, Johnson & Johnson Vision, or any other Johnson & Johnson Operating Company (e.g., DePuy, Ethicon, Janssen, etc.)

### Is Johnson & Johnson Vision the same thing as the Johnson & Johnson Foundation?

No, the [Johnson & Johnson Foundation](#) is a registered charitable organization currently operating globally as Johnson & Johnson Foundation US (founded 1953) and Johnson & Johnson Foundation Scotland (founded 2007)

- **Note:** our Johnson & Johnson Vision charitable contributions process is not related to any funding provided—or programs/initiatives overseen—by the Johnson & Johnson Foundation

## About the charitable contributions process

### When does the Johnson & Johnson Vision contributions cycle open for application submissions?

The application cycle timelines vary from year-to-year, so applicants are encouraged to review the application timelines located on our [corporate social responsibility webpage](#) prior to applying

- **Note:** applications submitted prior to the start of our annual application cycle—or after it has closed for the year—are ineligible for funding consideration and will be declined<sup>1</sup>

### How often may we submit apply for Johnson & Johnson Vision contributions consideration?

Eligible applicants may submit one charitable contributions application per calendar year, regardless of the final funding decision (i.e., approved or declined)

- **Note:** refer to the eligibility guidelines on our corporate social responsibility webpage for a list of criteria that determine applicant eligibility

### If we submit a contributions application to Johnson & Johnson Vision, is funding guaranteed?<sup>2</sup>

No, submission of an application does not constitute an offer or guarantee of charitable contributions funding from Johnson & Johnson Vision

### If our organization received contributions funding from Johnson & Johnson Vision in a prior year, does our current application have a higher likelihood of being approved/awarded funding?

No, applications are independent occurrences evaluated competitively against other submitted requests – with priority given to innovative programs (aligned with our strategic focus areas) that have measurable outcomes. At a minimum, the applicant should include information on:

- The activities (and associated goals) for the program in which funding is being requested
  - The anticipated community engagement/participation rate for the program
  - How the specific program currently makes a difference in the community and/or participants' lives
  - How the program results/metrics are substantiated (e.g., community feedback, changes in knowledge/skills/behaviors, participant success stories, etc.)

### How soon after applying will we be notified of our application's funding decision?

Most applicants are notified of the final decision within 90 days of submitting their application:

- Approved for the amount requested in the contributions application
- Approved for less than requested in the contributions application
- Declined
